HEALTH BENEFITS

Tailored for You

Your well-being is important to us, so we provide comprehensive health benefits for full-time employees. You and your eligible dependents can access these benefits starting on the first of the month following 60 days of employment.

Our Lionheart Medical Plan offers extensive coverage without the constraints of a network, giving you the freedom to choose your own providers (except for prescriptions). We truly invest in your health by covering most of the cost of this plan: you're only responsible for 12 to 19% of the total monthly cost. You have the flexibility to select your preferred medical provider or utilize the convenient Telehealth service at no additional cost.

This plan consists of four integrated parts working together to ensure you receive comprehensive medical coverage.

- Christian Healthcare Ministries (CHM)
 covers medical events over \$1000 including
 preventative and wellness visits. Rest assured,
 your medical expenses will be covered starting
 from the first dollar, and you can submit bills
 up to an unlimited amount.
- We provide a Health Reimbursement Account (HRA), funded by us, and administered through a convenient debit card for easy access. These funds can be used for qualifying expenses under \$1000, further enhancing your coverage.
- Last year, 96% of our employees had no out-of-pocket costs with our plan! If you do have out-of-pocket costs, after reaching the maximum Lionheart covers additional costs through our Ministry Fund. While you are responsible for the Maximum Out-Of-Pocket (MOOP) expenses after any medical event not covered by CHM and once your HRA funds have been exhausted, our Ministry Fund, also funded by Lionheart, steps in to cover additional costs beyond your MOOP.

With our comprehensive health benefits we ensure you have peace of mind and the necessary support to prioritize your well-being and that of your loved ones.
